NON-PROFIT CORPORATION ARTICLES OF INCORPORATION

Pursuant to §24.03 RCW of the laws of the State of Washington, the undersigned majority of whom are citizens of the United States, do hereby submit these Articles of Incorporation for the purpose of forming a Non-profit Corporation organized for charitable purposes.

ARTICLE 1

Name: The name of the corporation is Kotor Kitties.

ARTICLE 2

Existence: The corporation shall have perpetual existence.

ARTICLE 3

Effective Date: The effective date of incorporation shall be upon filing by the Secretary of State.

ARTICLE 4

Members: The corporation will not have members.


ARTICLE 5

Registered Agent and Office

ARTICLE 8

Directors: The directors will be elected, maintained, and appointed in accordance with the corporation's bylaws. The corporation's initial directors are as follows:

ARTICLE 9

Indemnification: The corporation does indemnify any directors, officers, employees, incorporators, and members of the corporation from any liability regarding the corporation and the affairs of the corporation, unless the person fraudulently and intentionally violated the law and/or maliciously conducted acts to damage and/or defraud the corporation, or as otherwise provided under applicable statute.

ARTICLE 10

The purpose of Kotor Kitties is exclusively for charitable, purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the internal revenue code, or the corresponding section of any future federal tax code.

The mission of Kotor Kitties is to help the homeless street animals of Montenegro lead healthier lives and to humanely reduce the homeless animal population through targeted spay/neuter surgery. Initially focused on cats in Kotor Municipality, we will routinely provide ancillary

medical care, such as vaccines and flea control, to those animals we sterilize.

In support of our Mission and to ensure its continued effectiveness, Kotor Kitties will engage in educational campaigns within the communities with which we work, recruit volunteers to provide transportation and foster care for short-term medical or developmental needs, encourage community engagement, and promote kindness and compassion for the homeless animals living in those communities through appropriate models of feeding and care.

We also seek to support and coordinate with other animal welfare groups in Montenegro to: share resources and educational materials, avoid duplication of services, and eventually develop sufficient resources to allow expansion of our targeted sterilization program into those communities where on-going success is likely.

ARTICLE 11

Prohibited Activities: No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 11.


No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE 12

Distributions Upon Dissolution: Upon the winding up and dissolution of the corporation, the assets of the corporation remaining after payment of, or provision for payment of, all debts and liabilities of the corporation, shall be distributed to an organization or organizations, as determined by the board of directors, that recognized as exempt under section 501(c)(3) of the code or any successor provision, and used exclusively to accomplish the purposes for which this corporation is organized.
